### About CPWA

The California Perinatal Wellness Alliance (CPWA) is a survivor- and community-led coalition advancing perinatal mental health and justice across California. CPWA mobilizes survivors, families, providers, and advocates to transform fragmented perinatal mental health systems through storytelling, organizing, and policy change — including the advancement of Senate Bill 626.

### Internship Overview

The intern will support CPWA's storytelling, advocacy, and coalition work, with a scope that can be tailored to their interests. This is a unique opportunity to gain hands-on experience in grassroots advocacy, narrative change, and coalition-building at the state level.

### Key Responsibilities

- **Storytelling Campaign & Communications**
  - Implement CPWA's statewide *Breaking the Silence* storybook campaign
  - Conduct outreach to missing audiences (fathers, LGBTQ+ parents, rural areas, etc.)
  - Support social media, newsletters, and media engagement to amplify stories
- **Policy Advocacy & SB 626**
  - Attend virtual coalition strategy meetings and advocacy events as capacity allows
  - Support legislative outreach, scheduling, and partner engagement coordination
  - Help draft and track support letters, talking points, and advocacy resources
- **Coalition-Building & Partner Engagement**
  - Conduct outreach to partners and stakeholders to expand CPWA's network
  - Track sign-ons and maintain up-to-date coalition contact lists
  - Support coalition communications, logistics, and follow-up

### Qualifications

- Strong interest in public health, policy, maternal/child health, or social justice advocacy
- Excellent written and verbal communication skills
- Highly organized, detail-oriented, and able to manage multiple priorities
- Comfortable working with sensitive stories in a trauma-informed way
- Experience with Google Suite, Canva, or social media management a plus
- Graduate students in Public Health, Public Policy, or Social Work encouraged to apply
